FINDINGS OF FACT

WHEREAS, JOSEPH BRAUN, LE CENTER, MN, (APPLICANT); GLENDON BRAUN, LE CENTER, MN, (OWNER), has applied for a Conditional Use Permit to allow the applicant to transfer the development right from the SE 1/4 SW 1/4 to the SW 1/4 SW 1/4 in an Agriculture "A" District. Property is located in the SW 1/4, Section 36, Tyrone Township.

WHEREAS, the Le Sueur County Planning and Zoning Commission held on public hearing on March 9, 2017, in order to hear public testimony from the applicants as well as interested parties pertaining to and as provided by the Zoning Ordinance of Le Sueur County.

WHEREAS, the Le Sueur County Planning and Zoning Commission, acting as an advisory board to the Le Sueur County Board of Commissioners recommends approval of the application due to the following findings:

- 1. The conditional use will not be injurious to the use and enjoyment of other property in the immediate vicinity for the purposes already permitted, nor substantially diminishes and impairs property values within the immediate vicinity.
- 2. The establishment of the conditional use will not impede the normal and orderly development and improvement of surrounding vacant property for uses predominant in the area.
- 3. Adequate utilities, access roads, drainage and other facilities are being provided.
- 4. Adequate measures will be taken to provide sufficient off-street parking and loading space to serve the proposed use.
