PURPOSE: To hear testimony from interested parties and consider Variance and Appeal Applications, as provided by the

Zoning Ordinance of Le Sueur County, as described below.

and on the website on or after NOVEMBER 6, 2018.

ITEM #1: MILAN BEHR, ELYSIAN, MN, (APPLICANT\OWNER): Request that the County grant a Variance from the Le Sueur County Zoning Ordinance to allow the applicant to install a septic tank 4 feet from the West property line, and install a septic drainfield 0 feet from the road Right-Of-Way (ROW) and 9 feet from the dwelling in a Recreational Residential "RR" District on Lake Frances, a Recreational Development "RD" lake. Property is located at Lot 2, Muellerleile Subdivision, Section 33, Elysian Township. VARIANCE IS FOR PROPERTY LINE, ROAD ROW, AND STRUCTURE SETBACKS. (APPLICATION TABLED AT THE JUNE 21, 2018 AND SEPTEMBER 20, 2018 MEETINGS).

ITEM #2: NEAL & SHELLI GROVER, AMBOY, MN, (APPLICANT); SHELLI GROVER, AMBOY, MN, (OWNER): Request that the County grant a Variance from the Le Sueur County Zoning Ordinance to allow a total of 38.3 % impervious surface on a lot in a Recreational Residential "RR" District on Lake Washington, a Recreational Development "RD" lake. Property is located at Lots 3 & 4, 28 & 29, Linder Bay Subdivision, Section 17, Kasota Township. VARIANCE IS FOR IMPERVIOUS SURFACE.

ITEM #3: DWAYNE & GWYN PLOOG, CLEVELAND, MN, (APPLICANT/OWNER): Request that the County grant a Variance from the Le Sueur County Zoning Ordinance to allow the applicant to install a septic tank 140 feet from the Ordinary High Water Level (OHWL) and install a septic drainfield 163 feet from the OHWL in a Special Protection "SP" District on Lake Henry, a Natural Environment "NE" lake. Property is located in the SW 1/4, Section 34, Cleveland Township. VARIANCE IS FOR OHWL SETBACK.

ITEM #4: SCOTT ADAMS, ALBERT LEA, MN, (APPLICANT); SCOTT ADAMS (MILTON & ADAMS TRUST), ALBERT LEA, MN, (OWNER): Request that the County grant a Variance from the Le Sueur County Zoning Ordinance to allow the applicant to install a holding tank 2 feet from the property line and 3 feet from the road Right-Of-Way (ROW) in a Recreational Residential "RR" District, on Lake Tetonka, a Recreational Development "RD" lake. Property is located at Lots 30 & 31 Tetonka Beach Subdivision, Section 24, Elysian Township. VARIANCE IS FOR PROPERTY LINE AND ROAD ROW SETBACKS.
