RE: Transportation Alternatives Program (TAP) Grant

At the Le Sueur City Council level there has been one or two discussions regarding a sidewalk improvement plan for our City's sidewalks. I'm also working on a Safe Routes To School (SRTS) plan and soon construction will start on a Kingsway Drive Walkway Trail project. Now, another grant opportunity has come along (TAP) to improve our pedestrian walk ramps.

The attached map shows where the non-compliant pedestrian ramps are located within our City's sidewalk system. By replacing these 47 pedestrian ramps our sidewalk system will provide a safe and accessible transportation system throughout the City. A majority of these improvements are located in housing neighborhoods. The improvements will make our sidewalk system compliant with the American Disabilities Act (ADA) and will provide adequate transportation surface for ALL pedestrians and students while avoiding foot traffic along City streets.

If the grant is awarded, money will be dispersed for a 2017 or 2018 construction season. The second attachment is the probable cost of the project using 2013 construction cost and adding 16% for 2018 construction. The grant is a 80/20 split (20% of construction cost to be paid by the City) less the engineering, administrative and bonding fee. If the grant is awarded the City will be responsible for approximately \$50,757.00 (\$26,587.00 + \$24,170.00 = \$50,757.00).

In conclusion, the City of Le Sueur is a city of less than 5000 residents so we would need County Board approval to proceed with this project in concept and a resolution by the County Board outlying this will need to accompany the application I am preparing. I would like to submit MnDOT by January 30, 2014.
